<p>POLICIES</p>	
<p>Attendance policy</p>	<p>The student must attend 100% practical. In case of missing classes, the student must work off the missed class in accordance with the schedule of work, approved by the department in the presence of the relevant order of the dean's office.</p>

<p>Assessment policy</p>	<p>When mastering the materials of the student's discipline, a maximum of 5 points is assigned for each practical lesson (the grade is set in the traditional 4-point grading system). At the end of the academic year, the arithmetic mean of student performance is calculated. The maximum number of points that a student can get in practical classes during the academic year is 120. The number of student points is calculated by the formula 120 multiplied by the arithmetic mean and divided by 5. The form of the final module control - differential credit. The student is admitted to the differential credit provided that the requirements of the curriculum are met and if he has scored at least 72 points for the current academic activity, which corresponds to the average score for the current mark "3". The final module control is carried out according to the schedule at the last practical lesson of the semester (the maximum number of points that a student can score during the assembly is 80), includes control and evaluation of theoretical and practical training within all topics of the discipline. The final module control is carried out in the form of testing, with a score of "5" corresponds to 80 points, "4" - 64 points, "3" - 48 points, "2" - 0 points. In case of unsatisfactory result for the final module control, the student has the right to retake the test. Students who fail to take the test without good reason are considered to have received an unsatisfactory grade. The student's refusal to perform the final module test is certified as an unsatisfactory answer. Incentive points are added to the assessment of the discipline for the implementation of an individual research project (defense of student research work 12 points, presentation at the conference 5 points, poster presentation at the conference 4 points, abstracts 3 points). The total score in the discipline may not exceed 200 points.</p>
<p>Deadlines and course retake policy</p>	<p>In the case when the current success of the applicant is lower than 72 points, admission to the final module control can be obtained by test control on the base of questions covering all topics of the discipline (according to the schedule of the department). The applicant receives admission to the final module control in the event that he provided the correct answers to more than 60% of questions, his current score is increased to "72". In the event that the applicant receives an unsatisfactory grade for the final module control, he must retake it in an additional week in the form of testing. In this case, the maximum score that the applicant can receive for the final module control - "3" (48 points). After the second rearrangement, the final modular control in an additional week - the second rearrangement is carried out in the form of testing in the presence of the commission, the composition of which is determined by the dean's office. The maximum score that the applicant can receive for the final module control - "3" (48 points). After the second rearrangement of the final module control, all current scores received by the applicant for higher education in the discipline are canceled. The total grade for the discipline that a higher education applicant can receive after the 3rd re-examination of the final module control can not be more than "3", which corresponds to 120 points. The applicant must reschedule the final module control before the beginning of the next semester according to the schedule established by the dean's office.</p>

<p>Assessment appeals policy</p>	<p>The results of the module and semester assessment are subject to appeal. A student must lodge an appeal to the director/dean on the day of certification or after announcing the results, but no later than the next working day. The appeal commission is established by the director/dean's order. The appeal commission's decision may change the grade in case of violations revealed during the attestation.</p>
<p>Academic integrity policy</p>	<p>Participants must complete all tasks according to the course requirements independently. Participants are not allowed to cheat during the written module or summative test. The assignments should not contain plagiarism, facts of fabrication, falsification, cheating. Manifestations of other types of academic dishonesty determined by the Academic Integrity policy are also unacceptable. If a teacher reveals violations of academic integrity by students during the course, the former have the right to take one of the following actions: - to reduce points by up to 40% for practical assignments; - to give recommendations for improving and resubmitting mandatory homework assignments with the reduction of points by up to 25%; - to not accept mandatory homework assignments without the right to resubmit; - set a date for retaking the written module or the summative test with a reduction of points by up to 15%; - to not allow to retake the written module or the summative test.</p>
